TERMS AND CONDITIONS

1. Information on the offer form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. The Promoter is Electrolux Home Products Pty Ltd of 163 O’Riordan Street, Mascot NSW 2020 ABN 51 004 762 341 and its agents in the promotion, including their officers, employees and agents (collectively called the “Promoter”). No correspondence received concerning this promotion will be entered into.
3. The promotion commences on Tuesday 1st August 2017 and closes at 5.00pm AEST on Saturday 30th September 2017 (unless extended) (“Promotional Period”). This offer can be used in conjunction with the *"Receive 5% off when you spend \$5,000, 7.5% off when you spend \$7,500 and 10% off when you spend \$10,000"* AEG Promotional Offer during the Promotional Period.
4. This promotion is only open to Australian residents 18 years or over, who purchase 4 current AEG cooking, dishwashing or refrigeration appliances (“Participating Product”) in a single transaction from an Australian Authorised Sales Agent of AEG during the Promotional Period.
5. Employees (and their immediate families) of the Promoter, participating sales agents and agencies associated with this promotion are ineligible to claim. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.
6. For the purposes of these Terms and Conditions, the following definitions apply:
'Purchase' means order placed and payment made in full for the Participating Product/s during the Promotional Period from an Australian Authorised Sales Agent of AEG.
Purchase does not include:
 - (i) Orders not paid in full;
 - (ii) Purchases via eBay or similar online third party bidding or auction websites;
 - (iii) Purchases of second hand products;
 - (iv) Purchases by Electrolux staff and the staff's immediate family;
 - (v) Purchases made through any online discounter (including but not limited to shoppingsafari.com.au, thebargainhunter.com.au, shopbot.com.au);
 - (vi) Purchases made through any unauthorised sales agent or seller;
 - (vii) Purchases made directly from Electrolux Home Products Pty Ltd.
7. Valid claimants will be issued with a discount at point of purchase.
8. A claimant is entitled to a 50% discount off the normal price on their purchase of a 4th AEG cooking, dishwashing or refrigeration appliance in the one transaction. Discount is applied to the lowest priced product. Excludes AEG accessories.

9. The Promoter recommends that prior to purchasing a Participating Product the customer verifies that the retailer is authorised to participate in this Promotion.
10. Offer only applies to new customer Purchases made within the Promotional Period and paid in one transaction. Multiple appliance purchases must be ordered in the one transaction and must be delivered together. No split deliveries allowed.
11. Offer does not apply to damaged, display, ex-display or run out models.
12. The Promoter's decision is final and no correspondence will be entered into.
13. The discount is not transferable or exchangeable and cannot be taken as cash.
14. If circumstances result in the Promoter not being reasonably able to complete the promotion, the Promoter reserves the right to cancel, terminate, modify or suspend the promotion subject to any written directions from a relevant regulatory authority.
15. The Promoter will not be responsible for any incorrect, inaccurate or incomplete information communicated in the course of, or in connection with, this promotion if the deficiency is occasioned by any cause outside the reasonable control of the Promoter.

17. PLEASE NOTE: Purchasers of Participating Product/s for Government and Commercial contract sales, second quality (T2), and auction goods are excluded from this promotion. SECOND QUALITY GOODS (T2) means products bearing Serials Numbers with the prefix "A", "B" or "C".
