No correspondence received concerning this promotion will be entered into.
3. The promotion commences on Sunday 1st January 2017 and closes at 5.00pm AEST on Sunday 31st December 2017 (“Promotional Period”).
4. This promotion is only open to Australian residents 18 years or over, who spend \$5000 or more on any current AEG cooking appliances, dishwashers or accessories (“Participating Product”) in a single transaction from an Australian Authorised Sales Agent of AEG during the Promotional Period.
5. Employees (and their immediate families) of the Promoter, participating sales agents and agencies associated with this promotion are ineligible to claim. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.

 - (iii) Purchases of second hand products;
 - (iv) Purchases by Electrolux staff and the staff’s immediate family;
 - (v) Purchases made through any online discounter (including but not limited to shoppingsafari.com.au, thebargainhunter.com.au, shopbot.com.au);
 - (vi) Purchases made through any unauthorised sales agent or seller;
 - (vii) Purchases made directly from Electrolux Home Products Pty Ltd.
7. Valid claimants will be issued with a discount at point of purchase. The applicable discounts are detailed in clause 8 below.
8. A claimant is entitled to a variable discount based on their spend on Participating Products.
 - Spend \$5,000 - \$7,499 on Participating Products and receive 5% off;

- Spend \$7,500 - \$9,999 on Participating Products and receive 7.5% off;
 - Spend \$10,000 or over on Participating Products and receive 10% off;
