TERMS AND CONDITIONS

1. Information on the offer and how to claim the offer form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.

No correspondence received concerning this promotion will be entered into.
3. The promotion commences on Tuesday 1 August 2017 and closes at 5:00pm ESST Sunday 1 October 2017 (“Promotional Period”).

This promotion is only open to Australian residents, 18 years or over, who purchase a specified AEG Oven (“Participating Product”) (models detailed in clause 6 below) from an Australian Authorised Sales Agent of AEG for domestic use by that purchaser only at a residential address during the Promotional Period.
