TERMS AND CONDITIONS

1. Information on the offer form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. The Promoter is Electrolux Home Products Pty Ltd of 163 O’Riordan Street, Mascot NSW 2020 ABN 51 004 762 341 and its agents in the promotion, including their officers, employees and agents (collectively called the “Promoter”). No correspondence received concerning this promotion will be entered int.
3. The promotion commences on Friday 26th July 2019 and closes at 5.00pm AESDT on Monday 30th September 2019 (“Promotional Period:
4. This promotion is only open to Australian residents 18 years or over, who spend \$5,000 or more on any current AEG cooking appliances or dishwashers (“Participating Product”) in a single transaction from an Australian authorised sales agent of AEG during the Promotion Period.
5. Employees (and their immediate families) of the Promoter, participating sales agents and agencies associated with this promotion are ineligible to claim. Immediate family means any of the following: spouse, ex-spouse, de-facto-spouse, child or step-child (whether natural or by adoption), parent step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.
6. For the purpose of these Terms and Conditions, the following definitions apply: ‘Purchase’ means order placed and payment made in full for the Participating Product/s during the Promotion Period from an Australian Authorised Sales Agent of AEG. Purchase does not include:

 - ii. Purchase via eBay or similar online third party bidding or auction websites;
 - iii. Purchases of second hand products;
 - iv. Purchase by Electrolux staff and the staff’s immediate family;
 - v. Purchases made through any online discounter (including but not limited to shoppingsafari.com.au, thebargainhunter.com.au, shopbot.com.au);
 - vi. Purchases made through any unauthorised sales agent or seller;
 - vii. Purchases made directly from Electrolux Home Products Pty Ltd
7. Valid claimants will be issued with a discount at point of purchase. The applicable discounts are detailed in clause 8 below.
8. A claimant is entitled to a variable discount based on their spend on Participating Products:
 - Spend \$5,000 - \$7,499 on Participating Products and receive 10% off
 - Spend \$7,500 - \$9,999 on Participating Products and receive 15% off

- Spend \$10,000 or more on Participating Products and receive 20% off
9. Offer only applies to new customer Purchases made within the Promotion Period and paid in one transaction. Multiple appliance purchases must be ordered in the one transaction and must be delivered together. No split deliveries allowed.
