1. Information on the offer part of Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.

The Promoter is Electrolux Home Products Pty Ltd of 163 O’Riordan Street, Mascot NSW 2020 ABN 51 004 762 341 and its agents in the promotion., including their officers, employees and agents (collectively called the “Promoter”). No correspondence received concerning this promotion will be entered into.
3. The Promotion commences on Friday 15th March 2019 and closes on Sunday 27th March 2019 (“Promotional Period”)
4. This Promotion is only open to Australian residents 18 years or over, who Purchase a specified AEG cooking product in accordance with these Terms and Conditions (“Participating Product”) (models detailed in clause 6 below) from an Australian authorised sales agent of AEG during the Promotional Period.
5. Employees (and their immediate families) of the Promoter, participating sales agents and agencies associated with Promotion are ineligible to claim.
